The trail will be open to the public during this event and as such other people and their dogs (on and off leash) may be using the trail. Each entrant is responsible for maintaining control over his or her dogs at all times (before, during and after) the event. Each driver is 100% liable for the actions of their dogs. If you are unable to pass another trail user and or their dog without having them "engaged" by your team, it is your responsibility to STOP and maintain control of your team so that they are prevented from approaching other dogs and people on the trail.
